- a. **Hornsea 4.** Ørsted has taken the decision not to progress with the development of the Hornsea 4 offshore wind farm in its current form and will no longer deliver Hornsea 4 under the current Contract for Difference awarded.
- b. **Dogger Bank South Examining Authority Change.** A lead member of the Examining Authority has resigned and a new member appointed.
- c. **Ellerker Neighbourhood Plan.** The plan was read and noted, no comments will be submitted.
- d. **Permission Granted.** 22/02902/PLF The Workshop, Bridlington Road. 25/00593/PLF Land north east of 1 Breeze Lane.
- e. **Application 25/01339/PLF 3 Skipsea Road.** Construction of a 1.8-meter-high fence to front boundary to replace 2 metre plus high privet hedge. The Parish Council had no objections to this application.
